1.01 UNIVERSAL RIGHT TO AN EDUCATION

"All men of every race, condition, and age, since they enjoy the dignity of a human being, have an inalienable right to an education that is in keeping with their ultimate goal, their ability, and the culture and tradition of their country, in harmony with their fraternal association with other peoples in the fostering of true unity and peace on earth. For a true education aims at the formation of the human person in the pursuit of his ultimate end and the good of the societies of which, as man, he is a member, and in whose obligations as an adult, he will share." Declaration on Christian Education, *Gravissimum Educationis*, Vatican Council II

1.02 STATEMENT OF PHILOSOPHY

The Catholic schools of the Diocese of Little Rock seek to offer high quality academic programs which are integrated with religious truth and values. Students are prepared for life in today's Church and society and for leadership in society and the Church of tomorrow through a strong, basic, and contemporary curriculum which includes instruction and formation in the beliefs, values, and traditions of Catholic Christianity.

The development of the whole person of the student (spiritually, intellectually, personally, socially, and physically), is the focus of Catholic education. The teachers, as partners with the parents, play a significant role in this educational ministry as they daily witness to the meaning of mature faith and Christian living. They are selected with care and are challenged to on-going professional and spiritual growth.

1.03 GOALS

The broad goals of all Catholic schools are: to teach the Gospel message; to build a faith community; to worship God; and to be of Christian service. Specific goals include:

- To work closely with the home in educating children toward the fullness of Christian life.
- To create a Christian educational community where human knowledge, enlightened and enlivened by faith, is shared by teachers, students, and parents in a spirit of freedom and love.
- To develop religious understanding and provide opportunities for personal commitment to religious values.
- To teach specifically Catholic principles and Christian values.
- To offer personal experiences in Christian living through liturgy, sacramental life, prayer, guidance, and example.
- To encourage staff members to grow as Christians.
- To instruct in human knowledge and skills which enable students to actively participate in the parish community and society.
- To help each student develop a positive attitude toward lifelong education, including the power to think constructively, to solve problems, and to reason independently.
- To facilitate and improve the student's opportunity to learn.
- To play a significant role in raising national levels of knowledge, competence, and experience.

STANDARDS

1.04 STANDARD I - FAITH

Every Catholic school in the Diocese of Little Rock will provide a religious atmosphere and programs which foster and deepen the knowledge of the Catholic faith and practice of a Christian life.

- Each school will develop a faculty and student handbook which includes its philosophy and goals to correspond to the goals in the *Diocesan Manual of Policies and Procedures*. That policy manual will also contain the policies and procedures which pertain to that particular school. Current copies of these handbooks are to be available to the Office of Catholic Schools, school board, faculty, and parents. Each school will evaluate its policies annually.
- Each school will give top priority to religion in the curriculum and will use religion texts approved by the United States Conference of Catholic Bishops.
- Each parochial school will work closely with the parish for the preparation of the sacraments.
- Each school will provide opportunities for sacred liturgies. Prayer will be interspersed throughout the school day.
- Schools will integrate faith and life by promoting understanding of the teachings of the Catholic Church through instruction and activities concerning vocations, missions, world hunger, justice, peace, and respect for life.

1.05 STANDARD II - ACADEMICS

Every Catholic school in the Diocese will strive for the highest quality education and to this end every Catholic school will maintain the standards required by the Diocese.

- Each school will adhere to the policies and regulations outlined in the *Diocesan Manual of Policies and Procedures* concerning the operation of the school.
- Each school will follow the *In Spirit and Truth* curriculum guide for grades kindergarten-eighth.
- Classroom instruction is designed to engage and motivate all students, addressing the diverse
 needs and capabilities of each student, and accommodating students with special needs, as fully
 as possible.
- Curriculum instruction provides students with the knowledge, understanding, and skills to become creative, reflective, literate, critical and moral evaluators, problem solvers, decision makers, and socially responsible global citizens.

1.06 STANDARD III - EVANGELIZATION/SUPPORT

By reason of their evangelizing mission, Catholic schools should be available to all people who desire a Catholic school education for their children. (*Gravissimum Educationis*, 6: Code of Canon Law, Canons 793 #2: Renewing Our Commitment to Catholic Elementary and Secondary Schools in the Tired Millennium, Introduction)

- Parishioners will be encouraged by the pastor to support the parish school in a meaningful way, such as "Adopt-A-Student", periodic collections, fundraising activities, and volunteering time and talents.
- Parish tuition grants will be established for needy children.
- An educational trust fund will be maintained to ensure adequate support for the school.

1.00 INTRODUCTION

- Schools will adhere to the non-discriminatory policies in the *Diocesan Manual of Policies and Procedures*.
- Catholic schools will establish an admissions policy with Catholic students taking precedence over other students.

1.07 STANDARD IV - SCHOOL BOARD

Every Catholic school will have a school board which recognizes and respects the roles of the appropriate and legitimate authorities.

- The school board, representing the diversity of stakeholders, functions according to its approved constitution and bylaws.
- The school board maintains a relationship with the canonical administrator, (pastor or designee of the Bishop) marked by mutual trust, close cooperation, and continuing dialogue.
- The school board ensures financial plans and budgets are implemented, using current and effective business practices as a means of providing good stewardship of resources.
